Account Holder	Name of the company which, according to the bank, owns the account.
Full EFT Client Number	EFT contract number with sub-user indication.
Authorized EFT Contact	Employee in charge with signature rights towards Fides according to the Authorized Signature List.
BIC Bank (Client-to-Fides)	BIC which will be provided by the client in the delivered file as the receiver BIC.
Sending BIC Fides (Fides-to-Bank)	BIC to be entered by Fides as the sender BIC.
Action	Required Action selectable from drop-down menu: Open, Delete or Modify.
Account Number Format delivered by Client	Entered by the client, represents the account number used by the EFT services (left justified). Account number format which is delivered by the client.
Account Currency	Currency of the account in ISO-Code (e.g. CHF for Swiss Francs, USD for US-Dollar).
Account Limit Amount	Maximum amount per payment debiting the relevant account, to be selected from the drop-down menu or individual value could be added into the corresponding field, placed of the reference currency (not the account currency).
Reference Currency	Selectable Currency of the Account Limit Amount, which has no impact of the Account Currency.

SWIFT Contact	Contact person at the bank responsible for all technical aspects relating to SWIFT or the electronic banking systems.

Receiver BIC	BIC used by the bank to actually receive the payment.
